

ENVIRONMENTAL REQUIREMENTS FOR SUPPLIERS*

- The supplier is obliged to comply with all applicable environmental laws and regulations.
- 2. The supplier should strive to minimize the adverse impact on the environment in his activities, at every stage of the product's life.
- 3. The supplier should strive to reduce the consumption of raw materials and resources, as well as to minimize waste and pollution generated as part of its activities.
- 4. The Supplier is obliged to have valid permits or decisions required by applicable law, including those regarding the scope of environmental protection, in particular those that are necessary for the proper performance of the contract with the Company or works on the premises of SZCZĘŚNIAK Pojazdy Specjalne Sp. z o. o.
- 5. The supplier should meet the legal requirements of environmental protection, including in particular obligations related to: submitting a summary statement of information the scope of environmental use and the amount of fees payable to the Marshal's Office; registration in the BDO system, keeping records of waste, waste transfer cards and submitting appropriate reports; payment of product fee; water and sewage management; registration and reporting in KOBIZE.
- 6. Materials and products purchased by SZCZĘŚNIAK Pojazdy Specjalne Sp. z o. o. from suppliers must not contain any substances or materials prohibited by law or other regulations applicable in the supplier's country, the European Union, and in all countries to which the products resulting from them ultimately end up. Therefore, suppliers must comply with, among other things, REACH regulations in force in the European Union and its national/international equivalents.
- 7. The Supplier is obliged to ensure that the means of transport are maintained in good technical condition and meet the emission standards applicable to it. In the event of a failure of the supplier's means of transport (e.g. oil or other chemical spill) on the premises of SZCZĘŚNIAK Pojazdy Specjalne Sp. z o. o., the supplier or an entity acting on his behalf should be prepared to immediately prevent and remove the effects of such a failure.
- 8. The supplier is obliged to provide a safety data sheet for chemical substances or mixtures in Polish in accordance with applicable regulations at the stage of the request for quotation.
- 9. The supplier is obliged to mark the packaging with chemical substances or mixtures with a label in Polish, in accordance with applicable regulations.
- 10. SZCZĘŚNIAK Pojazdy Specjalne Sp. z o. o. supports international efforts to end the use of minerals from conflict-affected regions where the proceeds from their sale are used to incite violence and acts contrary to human rights.
- 11. SZCZĘŚNIAK Pojazdy Specjalne Sp. z o.o. suppliers should promote the development and implementation of technologies that affect the reduction of CO₂ emissions and energy consumption, and use logistics solutions with the least impact on the environment.
- 12. With the above in mind, SZCZĘŚNIAK Pojazdy Specialne Sp. z o. o. also encourages each supplier to implement an environmental management system for compliance with the requirements of ISO 14001:2015.
- 13. On the premises of SZCZĘŚNIAK Pojazdy Specjalne Sp. z o. o. policies and procedures related to occupational health and safety and environmental protection.
